

Self-Contained Cabinet Warranty

STANDARD WARRANTY

Arneg Oceania Pty Ltd warrants to the original purchaser of an Arneg/Oscartielle manufactured refrigeration cabinet for twelve (12) months PARTS EX FACTORY from the date of invoice.

Liability under this warranty is limited to providing part/s without charge.

Liability under this warranty DOES NOT INCLUDE: |

- Breakage of glass or plastic components or the replacements of fluorescent tubes or gaskets;
- Electrical faults caused by power surges or connection to inadequate or faulty power;
- Any loss, consequential loss, loss of profit, or any other economic loss, damage or expenses directly or indirectly arising from use inability to use the cabinet or from any other cause;
- Any part of the refrigerated cabinet which has been subject to alteration, incorrect installation, misuse, neglect abuse, accident or to damage caused by transportation, fire flood or act of God;
- Time spent in emptying the cabinet (removing the stock displayed in the cabinet);

OPTIONAL COMMISSIONING & 3 MONTHS LABOUR WARRANTY:

FOR AN ADDITIONAL COST

ARNEG OCEANIA P/L will provide commissioning on site of your cabinets including:

- start-up
- settings according to ambient conditions
- maintenance procedures with customer (i.e. condenser cleaning)
- 3 months labour warranty

Liability under this warranty DOES NOT INCLUDE:

- Travelling time in excess of 50 km from authorised service agent;
- Time spent in emptying the cabinet (removing the stock displayed in the cabinet);
- Installation or removal costs, other than standard labour costs, by Arneg Oceania Pty Ltd authorised agents during normal working hours.

The liability under this warranty is dependent on an assessment by Arneg Oceania Pty Ltd or by its authorised agent to determine the defect in workmanship or materials.

Arneg Oceania Pty Ltd does not guarantee that any service to be performed under this warranty will be carried out within any particular time limit.

Repairs to the cabinet must not have been attempted by any person other than an authorised repair agent.

Repairs attempted by a non authorised agent will invalidate the warranty.

Required spare parts may be supplied from a local refrigeration supplier upon orders for pick up placed exclusively by Arneg Oceania Pty Ltd.

WARRANTY PROCEDURE

Contact Arneg Oceania Pty Ltd by faxing to 02 96257392 the included "Warranty Claim Form" duly filled and signed by an authorized person in your organisation.

Advise cabinet model, serial number and purchase date.

Upon confirmation of cabinet details, Arneg Oceania Pty Ltd will issue a claim number and advise your closest authorised service agent.

NO warranty claim whatsoever will be accepted unless authorised by Arneg Oceania Pty Ltd prior to commencement of service of supply of parts.
